Personal Information

Personal Information we collect

Other than cookies, as described below, the only personal information Peaceful Warrior Coaching currently collects through its websites is the information you voluntarily give us when you use our sites. For example, you may use this site to contact Peaceful Warrior Coaching with questions and comments. When you fill out a form on our websites, you may provide your name and other contact information, including your company's name, your e-mail address, and your mailing address or the mailing address of your company or other personal information. If you do not wish to fill out all of the information on the form you are not required to do so. Most of our registration forms require only your name and e-mail address. How We Use Personal Information

Peaceful Warrior coaching uses the personal data information you provide to answer your question or resolve your problem. Peaceful Warrior Coaching and our affiliates also use this information to help us improve the content and functionality of our websites, to better understand our customers and markets, and to improve our products and services. If you so choose, Peaceful Warrior Coaching and our affiliates may use this information to contact you in the future to tell you about products or services we believe will be of interest to you. If we do so, each communication we send you will contain instructions permitting you to "opt-out" of receiving future communications. Similarly, we may provide "subscription" e-mail services, either directly or through affiliates, which enable you to receive current news about Peaceful Warrior Coaching products or services. For all such services, we will provide an opportunity to "opt-out" of, or cancel, the subscription.

Disclosing personal information

We may disclose your personal information to any of our employees, officers, insurers, Professional advisers, agents, suppliers or subcontractors insofar as reasonably necessary for the Purposes set out in this policy.

We may disclose your personal information to any member of our group of companies (this Means our subsidiaries, our ultimate holding company and all its subsidiaries) insofar as Reasonably necessary for the purposes set out in this policy.

We may disclose your personal information:

- (a) To the extent that we are required to do so by law;
- (b) In connection with any ongoing or prospective legal proceedings;
- (c) In order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk);
- (d) To the purchaser (or prospective purchaser) of any business or asset that we are (or are contemplating) selling; and
- (e) To any person who we reasonably believe may apply to a court or other competent authority for disclosure of that personal information where, in our reasonable opinion, such court or authority would be reasonably likely to order disclosure of that personal information.

Except as provided in this policy, we will not provide your personal information to third parties.

Cookies.

A cookie is a small piece of information that is sent to your browser and stored on your computer's hard drive. Cookies do not damage your computer and they cannot be used to discover the identity of a user. You can set your browser to notify you when you receive a cookie. This enables you to decide if you want to accept it or not and whether you are required to accept the cookie to view certain content. Peaceful Warrior Coaching may use cookies to "persist" a user session that is, to maintain connection with a user as he or she moves through an application or series of web pages. The purpose of cookies in this context is to remember user inputs. For example, a "shopping cart" application records purchases up until the user reaches

checkout. Personalization features also use cookies to identify groups of users and deliver appropriate content and services.

With Whom Do You Share Information?

We do not share with others any personal information that you provide to us through this website or through our Customer Service Department, except with your consent or as described in this Privacy Policy.

We engage third parties to perform services in connection with the operation of our business. Examples of these services include marketing and promotional material distribution, website evaluation, data analysis and, where applicable, data cleansing. We may provide personal information to these third parties, but we authorize them to use this information only in connection with the services they perform.

We may share non-personal information with our marketing partners, advertisers and others from time to time. Examples of such non-personal information include the number of users who visited this website during a specific time period or purchased a specific product through this website. This information generally is shared in an aggregated form.

We may release personal information if we believe in good faith that: the law or legal process requires it; we have received a valid administrative request from a law enforcement agency; or such release is necessary to protect the rights, property or safety of Peaceful Warrior Coaching, or any of our respective affiliates, business partners, customers or others.
